

**ORDINANCE #24-3
CITY OF CORNELL**

**AN ORDINANCE TO AMEND SECTION 11.11 AND SECTION 11.12 OF THE CITY OF
CORNELL MUNICIPAL CODE RELATING TO ATV/UTV ROUTES & OPERATION
CONDITIONS**

The Common Council of the City of Cornell, Wisconsin does ordain as follows:

SECTION I – REVISIONS TO CITY CODE SECTION 11.11

Section 11.11(1)(a)(1) of the City Code of Ordinances is hereby repealed thereby allowing ATV/UTV travel on County Highway CC Street.

Section 11.11 (1)(a)(1) is amended to now read (1) All of Highway 178;

Section 11.11(1)(a)(2) is amended to read (2) State Highway 64, except from Park Rd to County Highway CC;

Section 11.11(1)(a)(3) is amended to read (3) State Highway 64, except to cross at the intersections of 2nd Street, 5th Street, 8th Street, or 270th Street;

Section 11.11(1)(a)(4) is amended to read (4) State Highway 27, except to cross at the intersections of Bates Street, 5th Street, 8th Street or 270th Street;

SECTION II – REVISIONS TO CITY CODE SECTION 11.12

Section 11.12 is hereby repealed and recreated to read as follows:

11.12 CONDITIONS

As a condition of the use of this ATV/UTV route, the following requirements shall apply to all operators and passengers.

(1) All ATV operators at least 12 years of age and who are born on or after January 1, 1988 shall have a valid ATV safety certificate and be accompanied by a parent or legal guardian until possessing a valid driver's license. All UTV operators at least 12 years of age and who are born on or after January 1, 1988 shall have a valid ATV safety certificate and be accompanied by a parent or legal guardian until possessing a valid driver's license. All UTV operators must be at least 16 years of age when operating an ATV on any public roadway. All operators must also carry liability insurance and be able to provide proof thereof.

(2) No person who is under current driver's license Suspension, Revocation or cancellation for any reason, may operate an ATV upon City streets within the corporate limits of Cornell.

(3) All ATV operators shall observe posted roadway speed limits.

(4) All operators shall ride single file on the right side of the road and remain on the roadway.

(5) No ATV/UTV operator or passenger shall possess any opened receptacle containing alcoholic beverages.

(6) All operators shall yield to the right-of-way to all other vehicular traffic and pedestrians.

(7) No ATV or UTV may be operated on any street within the City limits unless it conforms to all noise, registration, and other equipment requirements as stated in the Wisconsin Statutes or the Municipal Code of the City of Cornell.

(8) Every ATV and UTV operating within the City must display a lighted headlight and taillight at all times and if operated after sunset must have directional lights.

(9) All operators or passengers under 18 years of age shall wear an approved helmet during operation of the ATV or UTV.

(10) Routes shall be signed in accordance with NR 64.12, and NR 64.12 (7) c.

This ordinance shall be effective after adoption, publication and routes have to be properly signed.
