

ORDINANCE #24-4

**AN ORDINANCE TO AMEND SECTIONS OF CHAPTER 2 OF THE CITY OF
CORNELL MUNICIPAL CODE**

The common council of the City of Cornell do ordain as follows:

SECTION I – AMEND SECTION 2.11 OFFICE OATH AND BOND ORDINANCE

Chapter 2, Section 2.11(2)(A) of the City Code of Ordinances is hereby amended to read as follows:

(2) BONDS

(A) General Provisions. The following officers of the City shall be required to execute and file an appropriate bond no less than the amount noted below: **In lieu of bonds the City may carry a \$100,000 crime/dishonesty policy which covers all employees.**

SECTION II – AMEND SECTION 2.13 MUNICIPAL COURT ORDINANCE

Chapter 2, Section 2.13(3) of the City Code of Ordinances is hereby amended to read as follows:

(3) The Municipal Court shall be presided over by a Municipal Judge who shall be elected at large on the first Tuesday in April **in every** other odd numbered year, commencing on the first Tuesday in April, 1969 and shall serve for a term of **four (4)** years commencing on May 1, in the year of their election.

SECTION III – AMEND SECTION 2.14 BOARD OF REVIEW ORDINANCE

Chapter 2, Section 2.14(1), 2.14(4)(a) and 2.14(4)(d) of the City Code of Ordinances are hereby amended to read as follows:

(1) MEMBERSHIP OF BOARD OF REVIEW. Pursuant to Section 70.46, Wisconsin Statutes, the Board of Review shall consist of the Mayor and

the City Administrator and the alderpersons each year who are serving in the second year of the two year term to which they are elected or appointed. They shall meet annually **as required by state statutes**. Four members of the Board shall constitute a quorum. The City Administrator shall be the Clerk of the Board of Review. No assessor for the City may serve on the Board of Review.

(a) The Board of Review of the City of Cornell will meet annually **as required by state statutes**. The meeting shall be at the City Hall unless otherwise designated by the Common Council. A majority of the members will be a quorum.

(d) The hours of the first meeting of the Board of Review of the City shall be a minimum of two (2) hours. The meeting shall be between 9:00 a.m. and 12:00 a.m. (midnight). The meeting hours will be **4:00 p.m. to 6:00 p.m.** unless otherwise set by Common Council action. Reference: Section 70.47(3)(a), Wisconsin Statutes.

SECTION IV --- PUBLICATION, POSTING AND EFFECTIVE DATE

This ordinance shall be effective upon publication as required by Wis. Stat. § 62.11(4).
